

How to Catch Creature Vote Contest

OFFICIAL RULES

IMPORTANT: Please read these Official Rules for the “How to Catch Creature Vote Contest” presented by **Sourcebooks, LLC** (“Sponsor”) before entering. By entering the contest, you agree to the terms of these Official Rules. These Official Rules shall govern in the event of any inconsistency with other Contest-related materials.

NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED. No other discounts, prizes, refunds or credits will otherwise be offered in the Contest.

ELIGIBILITY: The contest is open to all entrants who are 13 years of age or older at time of entry and are residents of the fifty (50) United States and the District of Columbia at time of entry. All federal, state, and local regulations apply. **LIMIT ONE ENTRY PER PERSON. VOID WHERE PROHIBITED OR RESTRICTED.** Any minor who enters the Contest must have the permission of the parent and/or guardian and must be able to show proof of such permission if requested by Sponsor. Employees of Sponsor Company its parents, subsidiaries, affiliates, suppliers, and agencies, and their immediate family members and persons living in their household are not eligible to enter the Contest. HOW TO ENTER: Contestants are asked to vote for a creature, create a trap, and upload the art on the website (<http://www.howtocatchclub.com/contests.html>). .

To be considered an entry, entrants should use craft materials, photography, or static digital animation to present a trap.

Sponsor is not responsible for incorrect or inaccurate entry of information by entrants; lost or late entries; or other errors or problems of any kind whether mechanical, human, or electronic. Incomplete or illegible entries will be voided. All entries become the property of Sponsor and will not be returned. If for any reason the Contest is not capable of being conducted as described in these rules, Sponsor shall have the right to cancel, terminate, modify or suspend the Contest.

Submissions may not include obscene, offensive or inappropriate (in Sponsor’s sole and absolute discretion) material or defame any person, or otherwise infringe on any person’s proprietary rights or infringe on any other copyright or trademark claim of any person or company. If you are submitting art, you are warranting to Sponsor that such art is your own, that it does not

infringe on the rights of a third party, or a copyright holder, or that you have permission from the copyright holder or owner before submitting it.

PRIZE:

One (1) Grand Prize Winner will receive the following: Their trap creation will be illustrated by series illustrator Andy Elkerton and included in finished book, with credit given on copyright page

Any and all taxes on the prize will be the responsibility of the winners. JUDGING/WINNER SELECTION:

1. **One (1) Winner** will be selected by a qualified panel of marketing professionals, chosen by Sponsor, author Adam Wallace, and illustrator Andy Elkerton, the week of October 11, 2020 from all eligible entries received by the entry deadline. Entries will be judged on style, content, originality and creativity, with equal weight being given to each criterion. Judges will look for posts that are original and creative. Judges will be considering posts based on how the art meets the criteria provided.

The decisions of the Sponsor with respect to the selection of the winners, and in regard to all matter relating to this Contest, shall be final and binding. Winners will be notified via telephone and/or email and must respond within five (5) days of receipt of email or telephone call. Winner may also be required to complete, execute and return an Affidavit of Eligibility and Release. If winner is a minor they must also have the permission to enter and provide Sponsor with the use of the art from a parent and/or guardian and must have such parent and/or guardian sign a release. The Winner may be required to provide a Federal Tax Identification Number to Sponsor for issuance of a 1099 form, in connection with receipt of this portion of the prize or the prize will be forfeited in its entirety. Noncompliance with these conditions may result in forfeiture of the Prize, and Sponsor reserves the right to select alternate winners in such circumstances.
